IP Training Activities / 知財研修活動

Regular course



Comprehensive

Offers IP management, IP strategy, License Strategy, and recent global trends with as many information and examples as possible.

Research

Mainly consists of exercises and debate sessions on case studies for IP lawsuits and how to write ideal specifications. Lectures are centered on self study under guidance of first-class expertise.

Advanced

Offers primo-lecture on IP lawsuits, International Contracts, and Judicial Precedents. This course is ideal for those who have finished Secondary Course or those with comparable qualification.

Secondary

Covers international treaties, patent system, civil law, and civil procedure code etc as well as four industrial property related laws. Designed to enhance the capability of IP staff who are already have certain amount of experiences or similar qualifications

Primary

Aims to acquire basic practical IP business skill for those who have finished Introductory Course or similar qualifications

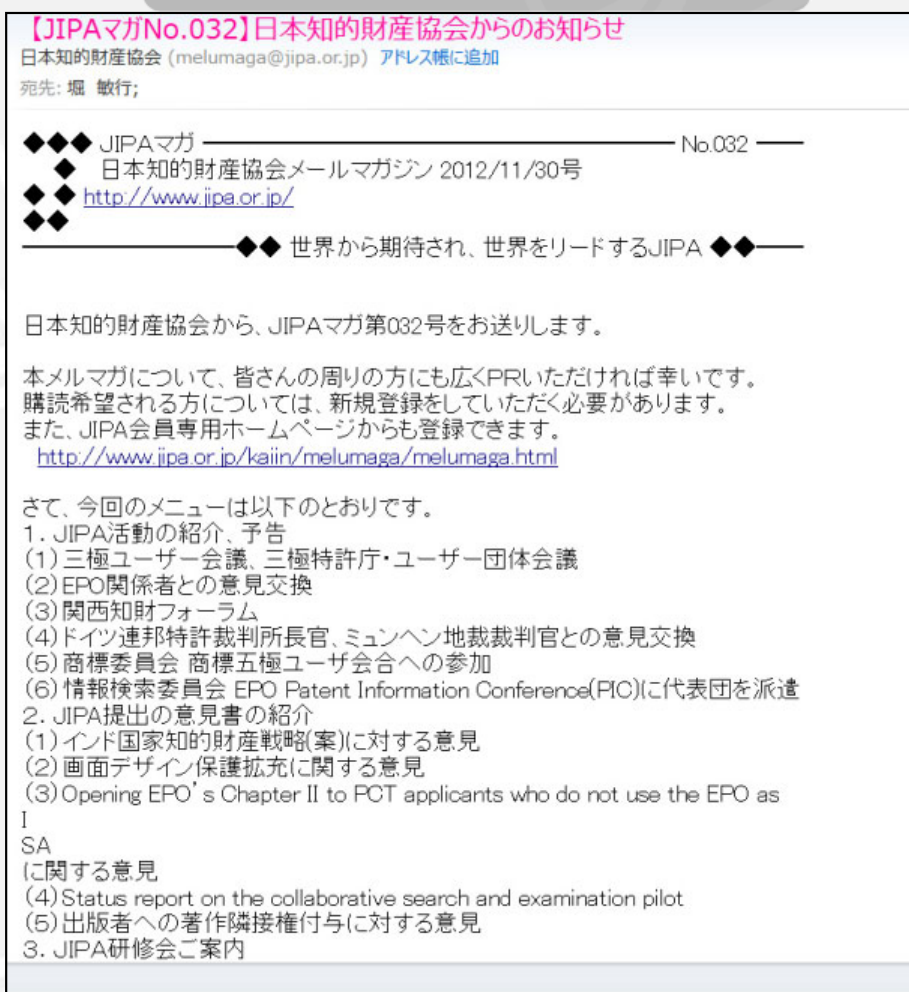
