JIPA Activity Plan for FY2005

IP activities and achievements thereof do not only involve the IP department but also affect corporate activities as a whole. JIPA has laid down an activity plan for FY2005 from the perspective of not only increasing the number of applications and expanding IP stock but also in terms of bringing about corporate growth and strengthening global competitiveness of Japanese companies as well as Japan through IP activities.

1. Operational Policy

(1) Provide member companies with support to achieve IP management that contributes to corporate management

(2) Make policy recommendations from a theoretical perspective, taking one-step forward beyond the level of merely providing information based on case studies.
